#### Following Protect Duty (Martyn's Law)

<u>Training</u> which our events team have all completed, we have implemented the following change to improve the safety and security of our events.

All event attendees (delegates and exhibitors) must now provide ID when collecting their attendee badge. ID is required for the following reasons.

- 1. To ensure a safe and secure environment for all attendees.
- 2. To protect attendees' personal data.
- 3. To ensure effective and reliable tracking.
- 4. To protect the financial integrity of the event.
